Dear Friends and Neighbors,

Hope everyone had a restful holiday break! We're kicking off the 2025 Legislative Session and the past couple weeks have been full of meetings to talk over, draft and submit bills. Feel free to reach out to me with your ideas. Here are some bills I've submitted, and many of them were inspired by constituents who wrote in about the issues they're facing:

- a bill to cap home insurance premium increases at 5% a year for low/moderate income seniors. It also requires insurers to provide 2 month's notice before discontinuing a policy or raising anyone's annual premium by more than 20% in one year.

- a bill to enable towns to have their own luxury real estate (over \$900,000) transfer tax, to help **fund affordable housing within the town**

- a bill to cap RI Energy's profit margins at 4% per year

Happening at the State House

- Gov McKee gave his State of the State address and released his budget. The
 House Finance and Senate Finance committees, over the coming months, will
 go through every article of the budget and make changes as new bills and
 appropriation requests come up. It's a much tighter budget year compared
 to previous years.

Blue Envelope program launches in Rhode Island

Very excited to announce the launch of the Blue Envelope program with Representative Azzinaro and DMV Director Walter Craddock. For drivers on the autism spectrum: You can pick up the Blue Envelope at any DMV office. You put your driver's license, registration, and emergency contact card in it and keep the envelope in your car. If you get pulled over, you hand the blue envelope to the officer, and the envelope contains instructions to help improve communication for both the officer and the driver.

why we should bring it to Rhode Island.
Together we made that happen.


URI Engineering Demos on Al used in Education, Personal Assistants








First Day of the 2025 Legislative Session

Responding to RI CyberAttack



Protect Your Personal Info:

#1: Freeze Your Credit

Freeze your credit for free by reaching out to <u>all three</u> credit reporting agencies so no one else can take out a loan or establish credit in your name.

#2: Monitor Your Credit

Contact one of the credit reporting agencies to order a **free credit report**.

#3: Request a Fraud Alert

Contact one of the credit reporting agencies to place a free fraud alert on your files. This lets creditors know they must contact you before any new accounts can be opened.

#4 Use Multifactor Authentication

This means having a safety backup for your passwords to help prove that it's really you before logging into your account.

#5 Be Aware

You may receive fake e-mails, phone calls or texts that look legitimate. **Never** share personal information through an unsolicited e-mail, call or text.

Over 600,000 Rhode Islanders' data was exposed in this cyberattack. Anyone who applied for state health coverage or health and human services programs should take the steps outlined above to protect their personal info. I highly encourage people to take about 15 minutes to freeze their credit so that no one can take out fraudulent loans or credit cards in your name. Here are the three major credit bureaus where you can request a freeze for free. You can always go back and unfreeze it if you want to apply for a new loan.

Those impacted will receive a letter on how to access free credit monitoring. According to our Constituent Services: applications for support received through the portal in December, but not approved prior to the cyberattack, will be honored and benefits will be paid retroactively upon approval.
